# WORKING AREAS OF LANDCARE ASSOCIATIONS (LCA)

- Supporting and advising famers and other land managers on available funding under the EU's Common Agricultural Policy (CAP) and other financial instruments, which foster species conservation and habitat restoration.
- Fostering new ways of creating income sources for agricultural value chains
  while preserving natural resources and biodiversity, such as direct marketing,
  landscape management, renewable energies, eco-tourism, participation in
  research and others.
- Regenerating biodiverse and resilient ecosystems in and outside Natura 2000 sites and other protected areas in cooperation with farmers and other
- stakeholders, e.g. renaturation of water bodies, rewetting of peatlands, restoration and (re)connecting habitats.
- Advising politicians and administrative bodies on necessary regulatory frameworks to protect and preserve our public goods biodiversity, water, soil and climate.
- Raising public awareness on sustainable farming practices that provide reliable living conditions for farmers, nutritious produce as well as ecosystem goods and services for the public.
